It is directed by the order of the Governor to say that the Governor has been pleased to accord sanction to the sum of Rs. 1,96,650/- (Rupees one lakh ninety six thousand six hundred fifty) only as Grant-in-aid for meeting the expansion towards implementation of first phase of a result oriented R&D project entitled "A hospital based epidemiological and nutrition survey of advanced cancer of Calcutta and 24 paranasal (S) and its management plan" to be implemented by Institute of Wetland Management Ecological Design, B-4, L.A. Block, Salt Lake, Calcutta - 91 for the duration of 3 (three) years.

Out of the amount sanctioned herein, Governor is further pleased to advance a sum of Rs. 1,96,650 /- (Rupees one lakh ninety six thousand six hundred fifty) only in one lump for execution of the first phase of the project.

The Governor has further been pleased to authorise Director, IWMSD to act as the D.D.O. in respect of the released amount. He will prepare the bill in T.R. Form No. 48 and present it before the O.S.D., Deptt. of Science & Technology and IES for countersignature before preferring the claim to the Treasury concerned.

Dr. H. Ghattacharyya, Superintendent, Bijoygarh State Hospital, Investigator-in-Charge of the said project will submit progress report and Director, IWMSD will submit the audited statement of expenditure and utilisation certificate in 3 copies in prescribed form in respect of the fund to this Deptt. immediately after completion of the first phase of the project.

The charge involved is debitiable to the head of account "3425-Other Scientific Research-60-others-200-Assistance to other scientific bodies-SP- State Plan (Annual plan and 9th plan)-001-Financial assistance to other Scientific Bodies [SI-7-V-31-Grants-in-aid-02-Other grants" in the current year's budget.

It is mentioned here as a condition of this sanction that the books & accounts and other connected documents of the recipient institution shall be made by the allottee available to the Comptroller & Auditor General of India or any other authority for scrutiny or audit, whenever & whatever necessary.
